#### **ANTI-RAGGING COMMITTEE**

The University Grants Commission framed "UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009" that should be mandatorily followed by all universities and colleges. A nationwide anti-ragging toll-free helpline 1800-180-5522 in 12 languages has been established which can be accessed by students in distress due to ragging. The Anti-ragging committee of the college shall make surprise raids in the hostel and other hotspots and is empowered to inspect places of potential ragging. It shall take appropriate actions including suitable punishments to those who are found guilty. Depending upon the nature and gravity of the offence as established by the Anti-Ragging Committee, the possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following: (a) Suspension from attending classes and academic privileges. (b) Withholding/withdrawing scholarship/fellowship and other benefits. (c) Debarring from

appearing in any test/examination or other evaluation process. (d) Withholding results. (e) Debarring from representing the institution in any regional, national or international meet, tournament, youth festival etc. (f) Suspension/expulsion from the hostel (g) Cancellation of admission (h) Rustication from the institution for periods ranging from 1 to 4 semesters (i) Expulsion from the institution and consequent debarring from admission to any other institution for a specified period (j) Fine ranging between Rupees 25,000/- and Rupees 2,50,000/-. (k) Collective punishment: When the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment.
